

## DÉCOR DENIA, CONSIGNMENT STORE AND AUCTIONEERS & VALUERS.

---

Terms and Conditions for receipt, storage and sale:

1. For entry into the Consignment shop the Vendor agrees to abide to a reducing price system indicated at the time of consignment into the store.

Quien deje artículos en la tienda se compromete a respetar un sistema de reducción de precios indicada en el momento de dejarlo en la tienda.

2. The Vendor understands and agrees to the item submitted being entered into the next available auction if not sold prior to the auction date.

El vendedor entiende y está de acuerdo que el artículo entrara en la próxima subasta disponible, si no se vende antes de la fecha de la subasta.

3. The item will usually be entered at no reserve unless a specifically agreed reserve has been applied prior to the sale.

El artículo será incluido en la próxima subasta sin reserva, a menos que se haya acordado una reserva/precio antes de la venta.

4. Any items withdrawn from sale by the vendor from the consignment date will attract a €10 withdrawal fee per item to cover contribute towards all administration costs.

Cualquier artículo retirado de la venta por el vendedor desde la fecha de entrada atraerá un cargo por retiro de €10 por artículo para cubrir gastos de administración.

Terms and Conditions to buy or sell at Décor Denia Auctions:

1. The following abbreviations next to a lot indicate the items condition:
  - a. T/W = Tested & working. Preliminary check carried out by staff.
  - b. GWO = Good Working Order described by the vendor.
  - c. V = It is necessary to add IVA to the hammer price.

Todos Los Lotes con una 'V' despues del numero LOTE es precio de martillo mas IVA.

2. All purchasers must register with the auction office. ID will be required to obtain a bidding number.

Todos los campradores deben registrarse, con identification, y obtener un numero de subasta.

3. At the fall of the hammer, all lots shall be, in every respect, at the absolute risk of the purchaser, including those of fire, theft and accidental damage sustained to lots by the removal from the saleroom.

A caer el martillo, todos los articulos comprados se hacen responsibilidad del comprador, incluyendo para incendio, robo, o dano causado por el retiro de otros articulos.

4. All lots sold incur a 15% ± IVA Buyers premium which will be added to the hammer price.

Potential purchasers should satisfy themselves of general description, origin, authenticity, quality, age, weight and size by physical inspections of the Lots prior to bidding. Décor Denia act as agents only and disclaim responsibility by either the Vender or purchaser nor do they guarantee the title of any Lots sold by them or be held responsible for any defect in such title.**

**Todos los articulos se venden como visto y no llevan garantia. El Comprador debe inspeccionar los articulos ofrecidos antes de la subasta, comprobando origen, authencidad, calidad, edad, peso, tamano y descripcion general. Los articulos se venden en su estado actual, incluyendo faltas, imperfecciones o erros de descipcion. Décor Denia es agente y desclama responsabilidad hacia vendedor o comprador o articulos vendidos.**

6. Electrical/mechanical goods are sold on the strict understanding that these are untested, without warranties or any guarantees as to serviceability or working order.

Articulos electricos o mecanicos se venden SIN HABER SIDO COMPROBADOS, y sin garantia de funcionamiento o service tecnico.

7. Persons handling lots do so at their own risk and shall make good all loss damage sustained to item. The Auctioneer will assess any damage and associated costs and their decision is final.

El Comprador maneja artículos en venta a su propio riesgo y se hace responsable por daños ocasionados. El coste de tal dano se decide Décor Denia y su decisión es final.

8. The Auctioneers may divide, combine, add to or withdraw lots and make any catalogue alterations without notice or reason. They will regulate bidding, accept or reject any bid (at their absolute discretion and without justification) and bid on behalf of the Vendor, where there is a reserve price or at their authorized discretion.

Décor Denia se puede dividir, combinar, añadir o retirar artículos, o alterar el catálogo sin aviso ni razón. Décor Denia, acepta o rechaza (a su discreción y sin justificación) y apostar por parte del Vendedor cuando hay un precio de reserva o con su discreción autorizada.

9. Purchasers shall pay for and remove lots purchased within 24Hrs of the end of the sale. Items are removed at the purchaser's own risk and expense. Items remaining after this period without prior arrangement will incur an additional storage charge of 5Euro per day per item.

El Comprador pagará y retirará artículos a su propio riesgo y coste después de la subasta. Artículos que permanezcan almacenados después del período contratado serán sujetos a un cargo de 5 Euro por artículo por día.

#### 10. **Spanish Vehicle Purchase Requirements**

The following Original documentation is required:

- a. NIE.
- b. Padron (No older than 3 months).
- c. Passport.
- d. Residencia Card (If you have Residencia card then a,b and c not required).

A 10% deposit on day of the sale and balance within 48Hrs. The name transfer must be done by Décor Denia Gestor, the transfer costs are the responsibility of the purchaser. **PLEASE DO NOT BID** if you cannot supply the above documentation. If you do and cannot provide within the allotted time period you will be liable for any lost commissions and fees due to failed sale.
